

## CAMP TERMS & CONDITIONS

By accepting this document, I give consent for my child to attend the following camp:

## Year 5 Residential Camp to Noosa North Shore on Tuesday 10 – Friday 13 August 2021.

I accept that the teachers and instructors will take appropriate disciplinary action in an attempt to ensure the safety, well-being, and successful conduct of the students who participate in the activities associated with the camp.

In the event of any illness or accident, I authorise the obtaining of such medical assistance as my child may require. In the event of any medical emergency during the camp, I appoint the supervising teacher-in-charge as our agent, with the right to arrange ambulance evacuation and medical treatment, if deemed necessary, and we cannot be contacted immediately.

I also accept the responsibility for payment of any expenses thus incurred which exceed the limit imposed by the school's insurance policy (student insurance details are available from the office).

Any such duly qualified doctor who treats our child in any emergency life-or-death situation has my consent to undertake life-saving surgery, including if necessary, the administration of anaesthetic and/or blood transfusions.

If you **do not** give consent to the above due to religious or other objections, please contact the school to give instructions on an alternative action in a life-or-death emergency situation.

If your child requires medication whilst on the camp, please provide the medication with a Pharmacy Label (Patient Name, Dosage, Doctor's Name) in a clearly labelled container or quick seal bag with completed medical form stating dosage and frequency and hand it to the teacher on the morning of the excursion.

## **CODE OF CONDUCT**

We believe that our students have the capacity to remain well behaved and respectful during this wonderful time together.

In order for this camp to run smoothly and safely for all involved, it is vital that the following Code of Conduct is brought to you and your child's attention:

- 1. Every student is a visitor and guest to the camp site, so **pleasant manners and extra special behaviour** is a necessity.
- 2. You are required to keep your accommodation neat and tidy and should report any damage that you may accidentally cause **immediately**.
- 3. You should follow **all** rules given to you by the St Paul's Staff, Parent Volunteers, and the Total Adventures Staff.

- 4. Safety is paramount when using all camp and activity equipment. You should always listen and follow instructions, especially if there is an activity you have never done before.
- 5. Look after yourself. It is up to you to shower, brush your teeth and clean up any mess you make.
- 6. You must **look after your classmates and show care for others**. **Treat other students and staff with respect** by speaking courteously and cooperating with one another, not making noise or having lights on after bedtime, using manners during mealtimes, and always trying your best, no matter who you are working with or what you are doing.

I have read and discussed the above Code of Conduct with my child. I understand that if my child engages in negative and unsafe behaviour, that there will be a step-by-step process of behaviour management concerning my child. This involves a first warning, followed by a second warning with an accompanied time-out from planned activity, and finally as a third step of action, parents will be phoned to come and collect their child, at their own expense, from camp. Camp fees will not be refunded.
