## **INSTRUMENT HIRE**



## 2022 Terms and Conditions

- 1. Parents/Guardians will ensure that the instrument, accessories (and tuition book where applicable) hired to their child by St Paul's Lutheran Primary School will be properly cared for and returned as required.
- 2. The instrument, accessories (and tuition book where applicable) remain the property of the school at all times.
- 3. Parents/Guardians will cover the instrument under their House and Contents Insurance or separate musical instrument insurance for the term of the hire.
- 4. Loss or damage of any instrument, accessory or book is the responsibility of the Parent/Guardian and should be reported immediately to the Performing Arts Co-ordinator at St Paul's. The school takes no responsibility for damage caused by student misuse, ignorance or abuse. All costs related to repairs are to be met by the Parent/Guardian, and completed by an authorised repairer approved by the school.
- 5. A reasonable supply of replacement strings will be provided by the school.
- 6. The instrument should only be used by the student to whom it is lent and by no other person.
- 7. Every care and attention should be given to the instrument during the period of the hire. Books and other bulky materials are not to be placed inside the instrument case, unless there is special provision for such items.
- 8. Many instruments come with accessories. It is the student's responsibility to ensure the security of these accessories as well as the instrument itself.
- 9. Missing accessories will result in replacement costs being covered by the Parent/Guardian.
- 10. The instrument, accessories (and tuition book where applicable) are returnable upon request to the school at any time, for inspection, repair and adjustment or for any other reason.
- 11. If, in the opinion of the Tutor and Performing Arts Co-ordinator, the student is not carrying out reasonable practice or effort, the hire may be terminated.
- 12. If the student does not observe school expectations at lessons and ensemble rehearsals, the hire may be terminated.
- 13. The instrument, accessories (and tuition book where applicable) are to be returned to St Paul's Lutheran Primary School by the end of the school year, as communicated by the Tutor and Performing Arts Co-ordinator.
